

# Integrated Approach Centralizes Reporting for a Combined Residency Program

---

## **Situation:**

Case Western Reserve University / University Hospital of Cleveland (UHC) School of Medicine is one of the leading Internal Medicine-Pediatrics Residency Programs in the U.S. Ranked No. 40 by U.S. News & World Report for its Primary Care training program. Case Western has more than 800 residents.

The various educational tracks coupled with the fact that the Internal Medicine and Pediatrics (Med/Peds) Programs are a combined program but operate independently of each other posed a significant challenge when it came to 360-degree resident evaluations and milestone reporting to the Accreditation Council for Graduate Medical Education (ACGME)

UHC School of Medicine enlisted the help of MyEvaluations.com to develop and implement an online reporting system that integrates the 360-degree performance data from two separate departments – Internal Medicine and Pediatrics – to generate a centralized milestone report. The new online system helped to ensure performance information captured on its Internal Medicine/Pediatrics residents was summative and spanned data from both departments.

At UHC, the Med/Peds residents switch between Internal Medicine and Pediatrics rotations every three months. Each rotation is department-specific and conducted in adjoined buildings allowing residents the full experience of pediatrics and adult medicine with independent and separate facilities. All the evaluations are assigned by the respective residency programs and reviewed by the Med/Peds Program Director, Dr. Steven Strausbaugh. This made semi-annual milestone performance reviews tedious.
